Owned by an artist and designer, this upgraded residence includes two bedrooms and two bathrooms with a total of 1,574 square feet of living space.

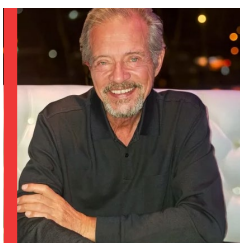
