## ABOUT LUKAZ CONDO

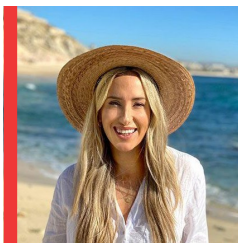

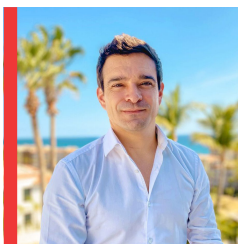
